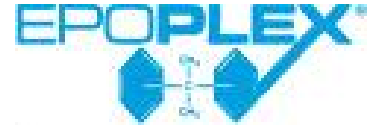

4. First-aid Measures**4.1 Description of First Aid Measures**

GENERAL NOTES: When symptoms persist or in all cases of doubt seek medical advice.
